2.00pm - 2.45pm, The Illegality Defence an Overlooked Tool

Barnaby Large (2007) undertakes employment, insolvency, commercial and family finance work. Barnaby was called to the Bar in 2007 and he advises in both contentious and non-contentious matters for a range of clients from insolvency practitioners to commercial entities and individuals. He has extensive experience of representing clients at first instance tribunals and has represented clients in both the Employment Appeal Tribunal and the High Court. He is a recipient of the status of one of the Attorney General's Pro Bono Heroes for his in work with the Free Representation Unit prior to coming to the Bar and remains a committed member of the Daniel Barnett's employment law bulletins.

Barnaby will be discussing the illegality defence, a powerful and often overlooked tool in the armoury when defending a claim. He will be sharing methods which have shed success on otherwise difficult litigation. The seminar aims to explore some of the history of the defence, it's application to a variety of different claims, the consequences of successful and unsuccessful defences as well as the costs implications of its use.

2.45pm - 3.30pm, Who is dead and is there life after death?

Stephen Large took up his post as cardio-thoracic surgeon to Papworth Hospital, Cambridge in 1989. That practice was initially broad, encompassing the whole spectrum of adult heart and lung disease, medical education as medical school sub-dean and medical administration. In 2001 fires were lit by the Open University's MBA programme but not hot enough to divert him from his life's interest in heart failure in its' many forms. He led the heart transplant service in Cambridge for 20 years from 1989 and now pursues his life long interest in improving donor heart quality and supply. This has recently given us heart transplantation from non-heart beating or DCD (donation after circulatory determined death) donors.

Who is dead and is there life after death? So what is the excitement about DCD hearts and the lure of heart transplantation? This talk will try and show why this is such an engaging subject. It will also reflect on our recognition of death and the wonder that can follow from the extraordinarily altruistic offer of organ donation. Stephen's story will, of course, describe the turn around of the lucky few with severe drug resistant heart failure who receive a change of heart. Finally he will make an attempt to see beyond today's horizon to present how we'll manage our failing hearts tomorrow.

3.30pm - 4.30pm, Civil Procedure and Costs Update

Edward Hurley (2010) is a strong and flexible advocate who is respected for his frank and no nonsense attitude. This has developed over the last several years through experience as a volunteer, paralegal, a civil litigator and now as a barrister; a bottom to the top perspective of law. Edward did not come from a traditional barrister background and fought his way to the Bar – this dogged determination is reflected in his case preparation and advocacy style. Edward has gathered a variety of experience including International Contract disputes, Immigration Law, Employment, Landlord and Tenant, Crime and general Civil. He continues to draw from his spectrum of experience but has begun to develop a central practice area of Personal Injury, Cost Disputes and Contractual Claims.

Helen Nugent (2007) focuses predominantly on Personal Injury (road traffic accidents, public and employers' liability), fatal accident, product liability and Clinical Negligence Claims. She advises both claimants and defendants and has over 7 years' experience in complex, multiple injury and catastrophic injury claims. Helen is developing her practice in occupational illness (including disease claims and cases arising from harassment and bullying at work); and she has been involved in cases involving provisional damages and claims for stepped periodical payments. She is both a contributor to the PI Brief Update and was recently elected as the Secretary to the APIL Barristers' Group.

Both Edward and Helen will be discussing the significant changes in Civil procedure and Costs update. They will also be taking a look at the latest developments, including:
