In her role in private practice, Sara has vast knowledge and experience of representing parents, family members (including intervenors), the Local Authority and Children's Guardian in public law children matters from the pre-proceedings phase right through to final hearing. Sara has particular experience of dealing with parents with learning difficulties. Sara has continued to expand her practice since transferring to the bar and represents parties in the following matters:

- Emergency contested applications where a Local Authority seeks the removal of a child Emergency Protection and Interim Care Orders.
- Placement Order and Adoption Proceedings.
- Applications under s34(4) s38(6) Children Act 1989.
- · Cases concerning domestic violence where sexual, physical or emotional abuse is alleged.
- · Cases including allegations of non-accidental injuries including infant death, multiple fractures and multiple bruising
- · Cases concerning alleged fabricated or induced illness
